MOTION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION TO BECOME A PARTY

Pursuant to Commission Rules of Practice and Procedure 1.4(a)(4) and 11.1, the California Independent System Operator Corporation (CAISO) hereby moves for leave to become a party to this proceeding.

The CAISO is a California public benefit company charged with reliably planning and operating the high voltage transmission system for its participating transmission owners (including San Diego Gas & Electric Company [SDG&E]) and running a day-ahead and real-time wholesale energy market. The CAISO has been an active participant in many Commission proceedings, including R.12-03-014, the long term procurement proceeding in which the Track 4 decision, D.14-03-004, was released earlier this year.

In R.12-03-014 Track 4, the CAISO presented studies of the SDG&E/SCE local capacity areas showing an urgent need for additional resources in light of the SONGS retirement in 2012 and the once-through-cooling environmental restrictions that will cause certain coastal resources to retire or repower, such as the year-end 2017 compliance deadline for the 946 MW Encina Power Plant. With the instant application, SDG&E seeks approval of a purchase power tolling agreement (PPTA) that can partially fill this local need on a timely basis. Given its location and

operational characteristics, the Carlsbad Energy Center would be a highly effective resource for addressing the local need identified in the Track 4 decision, which included approval for both conventional and preferred resources.

If this motion is granted, the CAISO intends to participate fully in this proceeding. Specifically, several parties have questioned whether a resource such as the Carlsbad Energy Center is needed in light of the transmission projects identified in the 2013-2014 transmission plan, approved by the CAISO Governing Board in March 2014.¹ The CAISO is uniquely situated to address this and other questions regarding the transmission plan and the assumptions that went into the studies supporting the transmission solutions approved by the Governing Board.² The CAISO notes that the need for resources in the SDG&E local area authorized by D.14-03-014 was not reduced by the transmission projects approved in the transmission plan.
