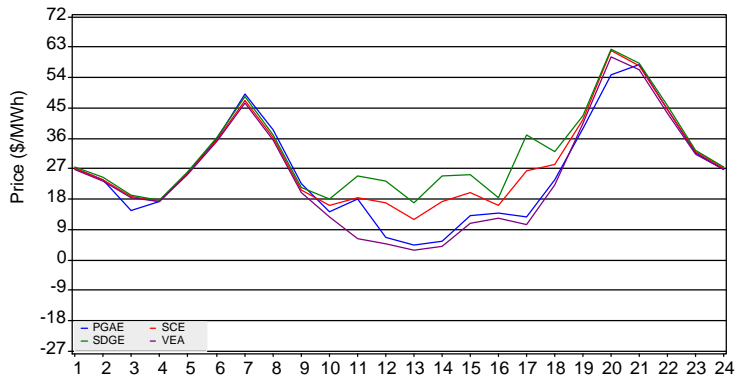


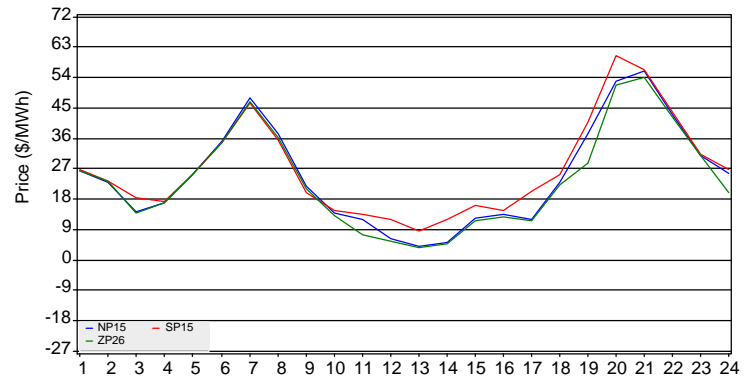

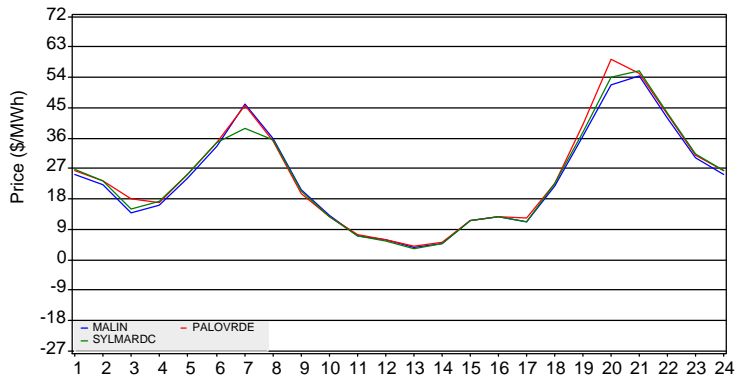
IFM Default LAP LMPs



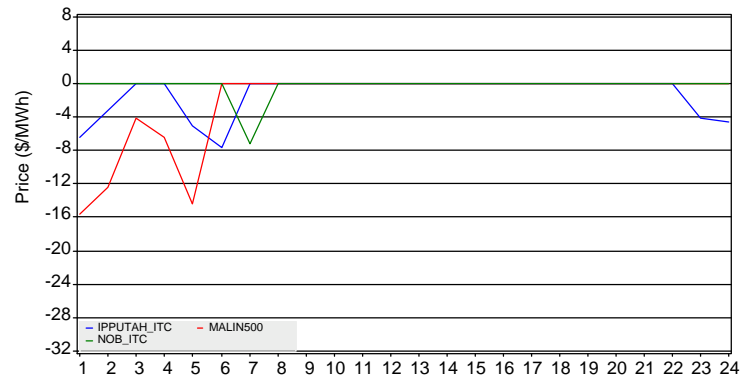
IFM Trading Hub LMPs

Selected IFM Intertie Shadow Prices



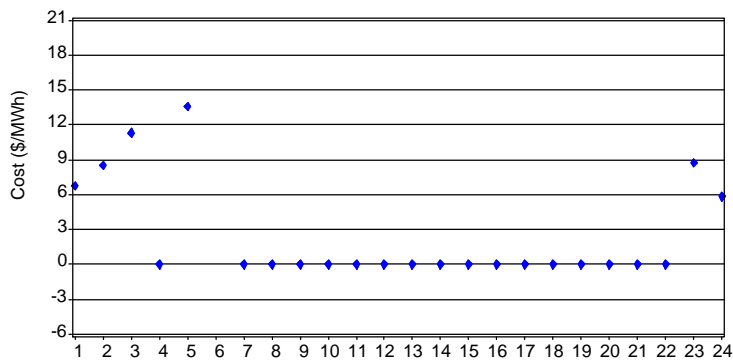

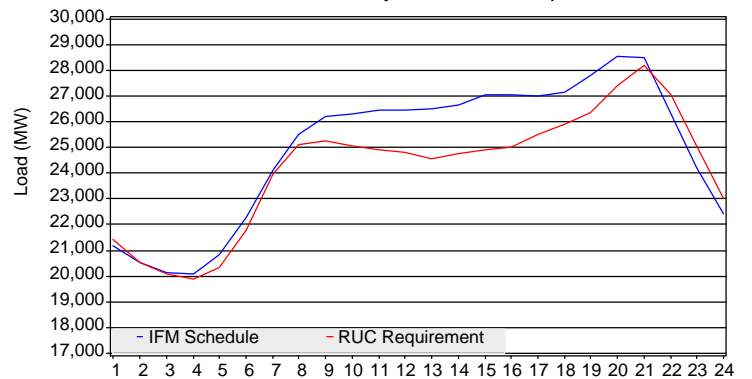

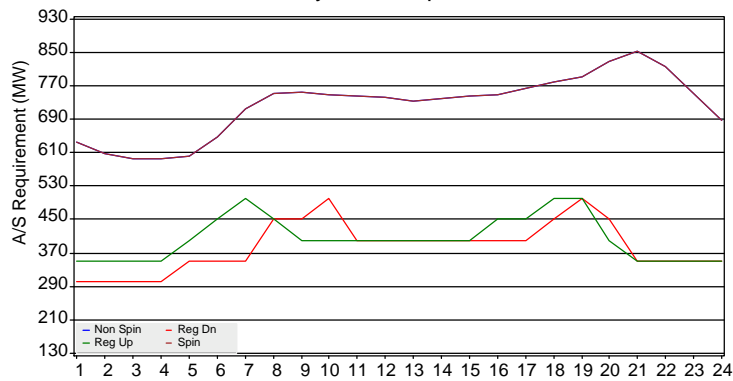
RUC Cost to Underscheduled Load



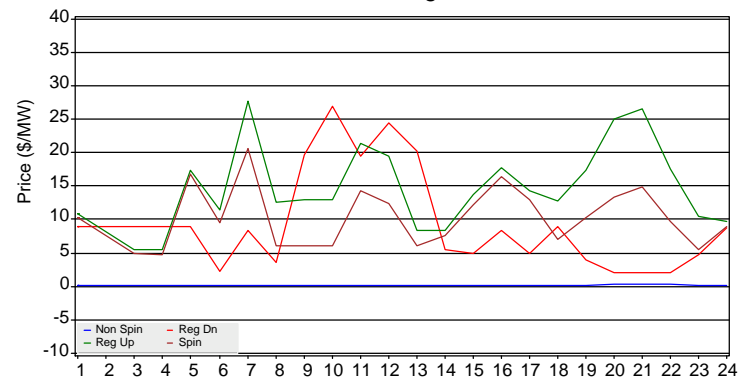
IFM Cleared Quantity and RUC Requirement



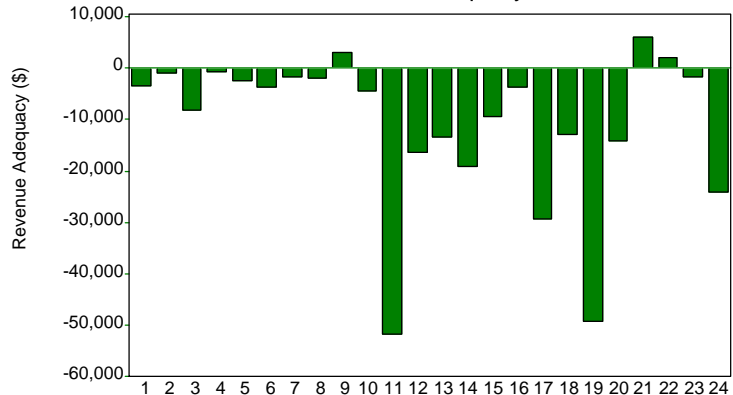
A/S System Requirement
