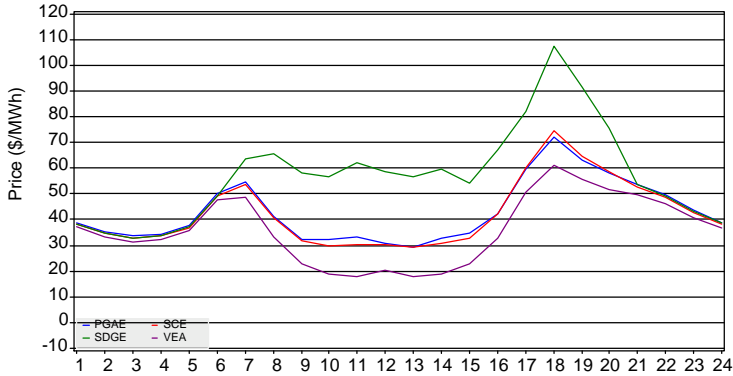


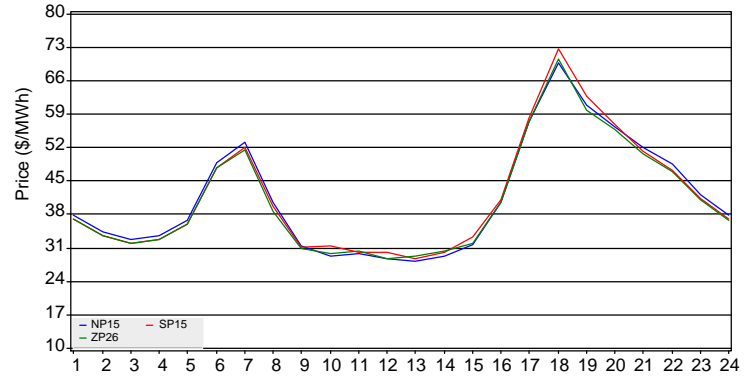

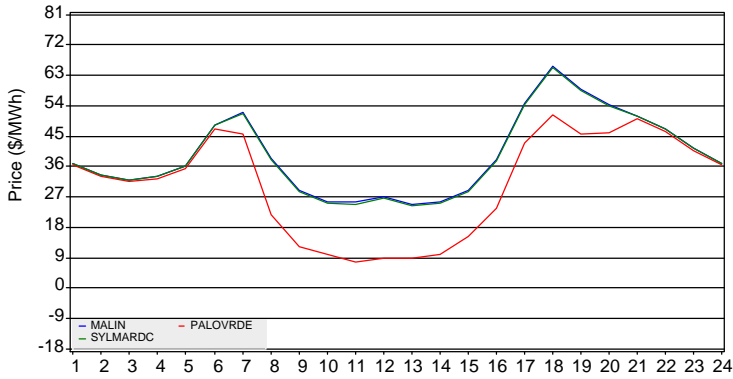
**IFM Default LAP LMPs**



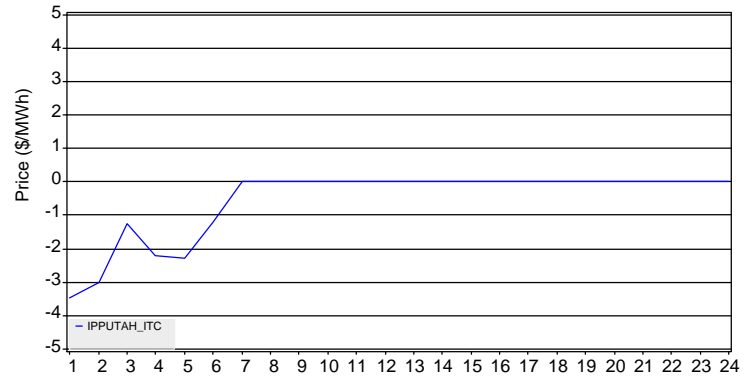
**IFM Trading Hub LMPs**

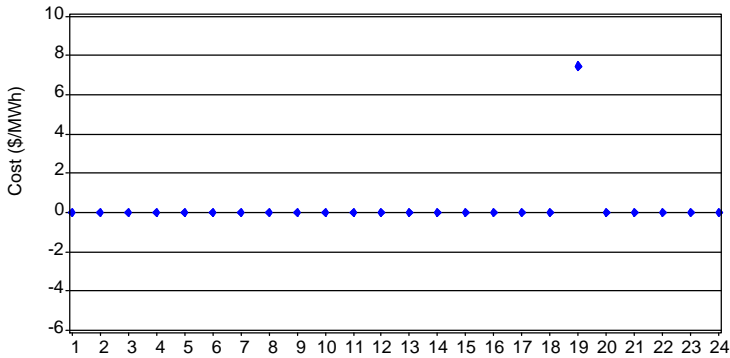

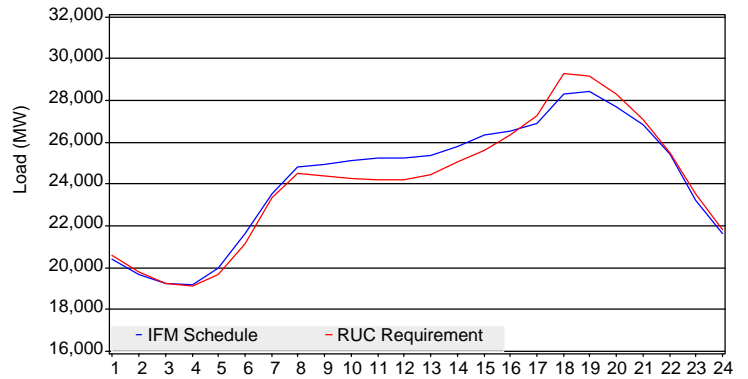

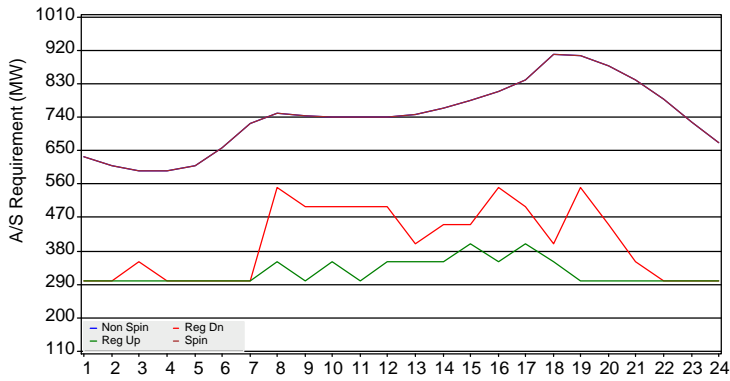
### RUC Cost to Underscheduled Load



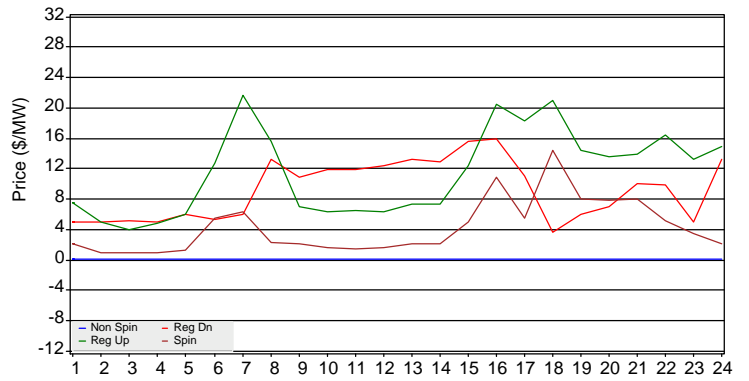
### IFM Cleared Quantity and RUC Requirement



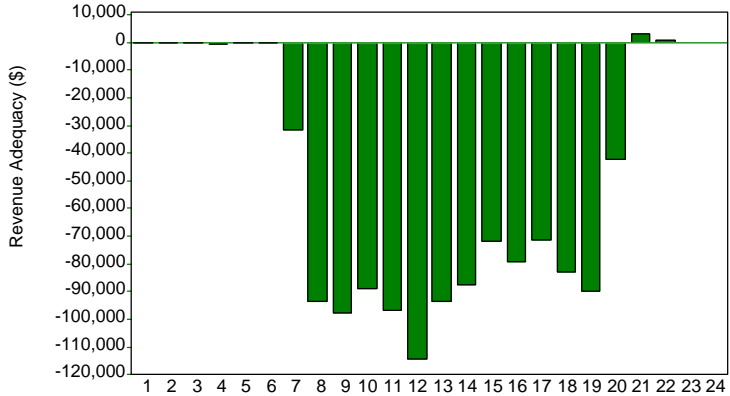
