DECISION ON THE GENERAL SESSION MINUTES

Governor Borenstein moved for approval of the ISO Board of Governors general session minutes for the July 21, 2022, meeting. The motion was seconded by Governor Bhagwat and approved 5-0.

CEO REPORT

WEIM GOVERNING BODY CHAIR REPORT

Robert Kondziolka, Chair of the WEIM Governing Body, provided an update from the August 30, 2022, WEIM Governing Body general session meeting, which included: highlights from ISO's CEO report; an update from the BOSR and RIF Chairs on activities their members have been engaging in; a WEIM Governance Review Committee update on the EDAM governance effort; highlights from the Q2 2022 WEIM benefits report; and an update provided by the ISO on several policy initiatives including EDAM, resource sufficiency evaluation, price formation, energy storage enhancements, transmission service and market scheduling priorities (wheel-throughs), and Washington State WEIM

greenhouse gas enhancements.

WEIM GOVERNANCE REVIEW COMMITTEE UPDATE

Therese Hampton, Chair of the WEIM Governance Review Committee, provided an update on stakeholder engagement activities related to the Committee's draft EDAM governance straw proposal. Chair Hampton noted that several stakeholders submitted comments on the proposal, particularly around the scope of joint authority. Chair Hampton concluded her update by highlighting the next steps in the EDAM governance process.

DECISION ON CONDITIONAL APPROVAL TO EXTEND RELIABILITY MUST-RUN CONTRACTS FOR 2023

Jeff Billinton, Director of Transmission Infrastructure Planning, presented the decisional item on conditional approval to extend existing reliability must-run contacts for 2023. Mr. Billinton noted that the ISO determines local and system-wide reliability needs through studies and also identifies resource adequacy capacity from specific units that may not be contracted by a load serving entity. Mr. Billinton indicated that conditional approvals are sought each year in September and highlighted the schedule of events related to this process. Mr. Billinton then reviewed the recommended contracts to be extended followed by the steps management intends to take subject to conditional approval of the contract extensions. Discussion ensued.
