Re: California Independent System Operator Corporation Amended Filing to Comply with Order No. 676-J Docket Nos. ER23-426-___; RM05-5-029; RM05-5-030

Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO)¹ submits this amended compliance filing to incorporate by reference certain Version 003.3 Standards for Business Practices and Communication Protocols of the Wholesale Electric Quadrant (WEQ) adopted by the North American Energy Standards Board (NAESB) and as incorporated by reference into the Commission's regulations in Order No. 676-J in the above referenced docket.² The CAISO requests that the Commission accept the enclosed tariff revisions to incorporate these NAESB standards into its tariff by reference, using an open-ended effective date of 12/31/9998.³

The CAISO also seeks leave to submit this compliance filing out of time. Due to an administrative oversight, and the fact that the CAISO currently has a waiver of the WEQ-001⁴ and WEQ-002 standards that include the changes required by the March 2, 2022 deadline, a compliance filing was not submitted at that time.

I. Background

In Order No. 676-J, the Commission amended its regulations to incorporate by reference the latest version (Version 003.3) of specified business practice standards that NAESB filed with the Commission on March 30, 2020. The Version 003.3 NAESB standards include updates to standards that the Commission previously incorporated by reference into its regulations.

The Version 003.3 standards include revisions related to the surety assessment on cybersecurity performed by Sandia National Laboratories designed to strengthen the practices and cybersecurity protections established within the standards.⁵ The standards also include revisions to support new OASIS functionality that will allow for the posting of third party offers of planning redispatch services as well as providing additional information regarding the curtailment of firm transmission service.⁶ The standards also include changes that were made to support consistency with the North American Electric Reliability Corporation (NERC) Reliability Standards.⁷ The standards also include additions, revisions, and reservations made to the WEQ-008 Transmission Load Relief (TLR) – Eastern Interconnection Business Practice Standards, which NAESB advises completes the standards development effort for the Parallel Flow Visualization (PFV) enhanced congestion management process.⁸ The standards also include five additional revisions to the OASIS suite of standards that were not made in response to Commission orders.⁹ In addition, the standards include revisions to the NAESB WEQ-023 Modeling Business Practice Standards.¹⁰ Finally, the Commission also revised 18 C.F.R. § 37.6(b)(2)(i) to codify that the calculation of Available Transfer Capability (ATC) must be conducted in manner that is transparent, consistent with system conditions and outages for the relevant timeframe, and not unduly discriminatory or preferential.11

requirements set forth in WEQ-001-13.1.1, WEQ-001-13.1.4, WEQ-001-13.1.5, and WEQ-001-16.

Order No. 676-J requires public utilities to revise their open access transmission tariffs to include the WEQ Version 003.3 Standards in two separate compliance filings. Specifically, in accordance with the schedule set forth in Order No. 676-J, public utilities are required to submit compliance filings for the WEQ cybersecurity standards and the PFV standards nine months after the publication of Order No. 676-J in the Federal Registry (*i.e.*, March 2, 2022). Public utilities' compliance filings for the rest of the WEQ Version 003.3 Standards are due twelve months after implementation of the WEQ Version 003.2 Standards, or no earlier than October 27, 2022.

II. Proposed Tariff Revisions

In accordance with Order No. 676-J, the CAISO has revised tariff section 7.3.3 to incorporate by reference WEQ-000 as set out in Appendix I of Order No. 676-J and 18 C.F.R. § 38.1 (2022). The CAISO also has incorporated by reference WEQ-008; however, this standard is inapplicable to the CAISO because it does not reside in the Eastern Interconnection. The CAISO also has revised tariff section 7.3.3 to list the WEQ-001 and WEQ-002 standards for which the CAISO has requested waiver, pursuant to the amended petition for waiver it is submitting the same day as this compliance filing. Adoption of the NAESB standards identified in Appendix I of Order No. 676-J does not require any substantive changes or revisions to the existing provisions of the CAISO tariff.

III. Effective Date

Pursuant to the directives in Order No. 676-J, the CAISO requests that the Commission accept the tariff revisions contained in this amended filing with an openended effective date of 12/31/9998.
