Informational Filing of Effective Date of Energy Storage Enhancements Tariff Amendment – Part 1

Dear Secretary Bose:

On March 31, 2023, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to implement the first phase of the CAISO's energy storage enhancements stakeholder initiative. By order issued June 1, 2023, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO partially implemented the tariff changes for energy storage enhancements initiative on July 1, 2023. Accordingly, the CAISO is submitting this informational filing to specify an effective date of July 1, 2023 for the tariff revisions accepted by the Commission in this docket.² The CAISO is requesting a waiver of the five-day implementation notification due to an administrative error regarding the actual effective date.

Cal. Indep. Sys. Operator Corp., 183 FERC ¶ 61,161 (2023). The Commission directed the CAISO to notify the Commission of the actual effective date of the Tariff revisions within five business days of their implementation, in an eTariff submittal using Type of Filing Code 150 – Report.

The CAISO is submitting the informational filing in eTariff using Type of Filing Code 150. Specifically, this informational filing updates the effective date for the Tariff Records for Section 30.5.2.7 and Section 39.7.1.8. The remaining tariff records submitted in the March 31, 2023 are still pending. The CAISO will submit an additional informational filing of the effective date in the future.
