**NOTICE OF EX PARTE COMMUNICATION BY
THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION**

Pursuant to Article 8 of the California Public Utilities Commission (Commission) Rules of Practice and Procedure, the California Independent System Operator Corporation (CAISO) hereby files this notice of the following oral ex parte communication with Matthew Tisdale, advisor to Commissioner Florio.

On May 28, 2015 from approximately 1:30 p.m. – 3:00 p.m., Ali Miremadi of the CAISO met with Mr. Tisdale. The meeting was held at the Commission building in San Francisco, California.

During this meeting, Mr. Miremadi discussed the scope of work for the load-modifying demand response working group, specifically with regard to the ongoing need for demand response spreadsheet information after bifurcation. Mr. Miremadi noted the CAISO proposal to continue with a modified daily spreadsheet to be delivered at 8:00 a.m., consistent with today’s practice, and a spreadsheet at 2:00 p.m. to reflect the next day RDRR planned participation. Mr. Miremadi also noted the possibility of automation at some point in the future after processes have stabilized.

The CAISO did not present any written materials during the course of this communication.
