# **Meeting Minutes Review**

The meeting minutes for the April 27<sup>th</sup> call have been posted.

## **Weekly Market Performance Report**

The weekly report covers the time period of April 19-May 2, 2017. The congestion in the day-ahead and real-time market on 6410\_CP5\_NG ended on April 25<sup>th</sup> because the transmission outage related to the nomogram ended. The root cause of real-time price excursions are provided in the report. Although outside this report, there was a Stage 1 Emergency on May 3<sup>rd</sup> and some analysis of this event will be discussed at the May 16<sup>th</sup> Market Planning and Performance Forum.

Q: What time was the Stage 1 Emergency?

**A**: It was on May 3, 2017 from 19:05 to 20:55.

A: The ISO will take this as an action item and report on it in a future Market Update Call.

**Q**: For some of the recent day-ahead market trade dates the mid-day prices are above \$0, what is driving this?

**A**: There were higher loads on these days.

**Q**: Can you provide more information on 6410\_CP5\_NG?

**Q**: Are the high prices on the 24702\_KRAMER \_\_115\_B2 nodal group constraint in the day-head market for May 11 valid?

A: No, this congestion was caused by a software defect and the prices will be corrected.

During the week of April 24-28, 2017, the ISO processed 129 price corrections due to software defects and data input errors. During the week of May 1-5, 2017, the ISO processed 9 price corrections due to software defects and data input errors.
