# ADMINISTRATIVE LAW JUDGE'S RULING INCREASING THE MAXIMUM NUMBER OF FACILITATED WORKSHOP DAYS AND REVISING THE WORKSHOP SCHEDULE

## 1. Background

The Assigned Commissioner's Ruling and Scoping Memo for Phase 3 of this Proceeding, dated June 1, 2012 (hereafter, "the Phase 3 Scoping Memo"), established the following schedule for facilitated workshops for Tracks 1 and 2:

Workshop Report filed and served. Exact date to be determined by the workshop participants.	February 2013
Opening briefs on the Workshop Report due three (3) weeks after the report is filed and served. ( <b>Note 1</b> )	March 2013
Reply briefs due two (2) weeks after opening briefs are filed and served. ( <b>Note 1</b> )	March – April 2013

Proposed Decision mailed.	August – September 2013
Proposed Decision considered at Commission meeting.	September – October 2013

<u>Note 1</u>: The briefs and reply briefs should follow a common outline agreed to by the parties in the facilitated workshops.

The Administrative Law Judge's Ruling Regarding the Pre-Workshop Conference and Workshop Facilitators dated October 24, 2012, stated that the Commission-appointed workshop facilitator(s) would be available for up to four workshop days in San Francisco.

Subsequently, at the Pre-Workshop Conference held on November 13, 2012, the workshop participants agreed that more than four facilitated workshop days are needed due to the number and complexity of the issues, and that the workshop report needs to be submitted later than contemplated by the Phase 3 Scoping Memo because of the additional workshop days.

## 2. Ruling

In response to the consensus at the Pre-Workshop Conference, this ruling notifies the workshop participants that the Commission-appointed facilitator(s) will be available for a maximum of eight (8) workshop days in San Francisco, with the exact number of days to be determined by the facilitator(s). This ruling also grants the workshop participants until May 1, 2013, to prepare and submit the Workshop Report for Tracks 1 and 2. The revised schedule is as follows:

Opening briefs re: Workshop Report due three (3) weeks after the report is filed & served. ( <b>Note 1</b> )	May 2013 (Approximate)
Reply briefs due two (2) weeks after opening briefs are filed & served. ( <b>Note 1</b> )	June 2013 (Approximate)
Proposed Decision (PD) mailed.	October 2013 (Approximate)
PD considered at Commission meeting.	November 2013 (Approximate)

**Note 1**: The briefs and reply briefs should follow a common outline agreed to by the parties in the facilitated workshops.

This ruling is being issued pursuant to Ruling Paragraph 1 of the Phase 3 Scoping Memo, which authorizes the assigned Administrative Law Judge to revise the schedule for Phase 3 of this proceeding.

### Therefore **IT IS RULED** that:

- 1. The maximum number of facilitated workshop days for Tracks 1 and 2 is increased to eight (8), with the exact number of facilitated workshop days to be determined by the facilitator(s).
  - 2. The proceeding schedule is revised as set forth in the body of this ruling. Dated November 20, 2012, at San Francisco, California.
