Informational Filing of Effective Date of Energy Storage Enhancements Tariff Amendment – Phase 1, Part 2 and Phase 2

Docket Nos. ER23-1533-\_\_\_ and ER23-2537-\_\_\_ (not consolidated)

## Dear Secretary Bose:

On March 31, 2023, in Docket No. ER23-1533, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to implement the first phase of the CAISO's energy storage enhancements stakeholder initiative. By order issued June 1, 2023, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.<sup>1</sup>

On July 17, the CAISO partially implemented the tariff changes for the energy storage enhancements, phase 1, initiative on July 1, 2023.<sup>2</sup>

The CAISO implemented the remaining tariff changes for the energy storage enhancements initiative, phase 1, on November 1, 2023. Accordingly,

The CAISO implemented part one of this initiative on July 1, 2023, which included tariff Section 30.5.2.7 and Section 39.7.1.8.

the CAISO is submitting this informational filing to specify an effective date of November 1, 2023 for the tariff revisions accepted by the Commission in docket number ER23-1533.<sup>3</sup>

On August 1, 2023, in Docket No. ER23-2537, the CAISO filed the second phase of the energy storage enhancement stakeholder initiative. By order issued September 29, 2023, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.<sup>4</sup>

The CAISO implemented the tariff changes for energy storage enhancements, phase 2, on November 1, 2023. Accordingly, the CAISO is submitting this informational filing to specify an effective date of November 1, 2023 for the tariff revisions accepted by the Commission in docket number ER23-2537.<sup>5</sup>

The CAISO has served copies of this filing on all the parties to the service list for these proceedings. In addition, the CAISO is posting this filing on the CAISO website.

The CAISO is submitting the informational filing in eTariff using Type of Filing Code 150. Specifically, this informational filing updates the effective date for the Tariff Records submitted on March 31, 2023 for Sections 8.4.1.1, 11.5.6.1.2, and 11.8.4.2.1 in docket number ER23-1533.
