Getting started

Resource project types to be created through NRI:

- Distributed Energy Resource (DERP)
- SCME EIM onboarding
- SCME EIM Updates
- Existing resources converting from ISOME to SCME

All other project types to be created through RIMS:

Focus of today's session

Creating projects in RIMS: Today's process

- Customer completes Project Details Form (PDF)
- Customer uploads PDF to RIMS
- RIMS creates a project using the following criteria:
 - RIMS validates project creation based on ≥ 84 days from implementation date
 - Documentation buckets 1 & 2 due no less than 84 days from implementation




WHAT IS CHANGING

NRI Bucket System and FNM Release Schedule

- The ISO “bucket” system is derived from the Full Network Model database release schedule based on a generation project's estimated implementation date
- These due dates specify the **acceptance** deadline in order to be considered for the desired FNM model build

RIMS changes align Bucket 1 & 2 due dates to FNM build cycle



How does project creation align with FNM build schedule?

Bucket 1 & 2 documentation must be **accepted** by this date

Project implementation date must be at least 15 days past this date

How do these date changes affect you, the RIMS customer?

- Updated version of PDF (version 12a) must be used going forward
- If you upload PDFs to RIMS using the old timelines, your projects may not be created
- Instead, you'll receive an email indicating that there was an error with the submission
- You will need to select a new implementation date and re-upload the PDF



Creating projects in RIMS: New process

PDF has been updated with new instructions

- Complete PDF (only new version 12a will be accepted)
- Upload to RIMS
- Project is created based on new criteria that checks:
 - Scope cut-off date (Customer Model Document Submission Deadline field), and
 - Implementation date is at least 15 calendar days past FNM build's production deployment effective date

California ISO Project Details Form

Submit a new request through the [Resource Interconnection Management System \(RIMS\) public site](#). 1) Fill out the "New Request" section 2) Choose the "NRI Project Details Form" drop down 3) Click "Register". A registration code will be emailed to the email contact in the New Request. 4) Place this code within the "Registration Code" section of the public site. 5) Click "submit" to access the upload screen for the project details form. You will receive an ISO Project code after the form validation is complete. The ISO project code will be used for all filenames.

RIG Reconfiguration, Meter Replacement and Meter Maintenance Project Types please only fill out rows 1, 2A- 2G, 3A-C, 6A, 7A-C only. 





Project **NOT** created – although imp date is 15 days after prod eff date, scope is **NOT** open

- Customer receives email with error message
- Must select new implementation date and re-upload PDF

Key Points

- RIMS will be updated to align the documentation due dates with the Full Network Model build cycle
- When selecting project implementation date, ensure the following:
 - 1) FNM DB scope window is still open for targeted model build, and
 - 2) Implementation date is at least 15 days past the model build's production deployment effective date
- The following items will be updated:
 - NRI Guide
 - RIMS Project Details Form
 - RIMS Quick Start Guide
