**Six Cities' Response:** The Six Cities support the CAISO's proposal to study the impacts of availability limitations on the ability of resources designated for Local RA to respond to dispatch directives and to maintain output levels as needed to sustain local reliability. However, the Draft Final Proposal does not provide a clear description of what action the CAISO will take when the outcome of such a study indicates that the designated Local RA resources are or may not be able to provide sufficient output to maintain reliability. The Six Cities request that the CAISO

provide further detail with respect to the measures it will apply to address any potential deficiency indicated by a Local RA study.
