Dear Secretary Boergers:

Enclosed for filing please find copies of tariff sheets for the California Independent System Operator Corporation ("ISO")¹ FERC Electric Tariff, submitted in compliance with the Commission's June 14, 2000 order in the above-referenced docket.

On April 14, 2000, the ISO filed Amendment No. 28 to the ISO Tariff in the above-referenced docket. In Amendment No. 28 the ISO proposed, among other things, to add a new section to the ISO Tariff, Section 2.3.5.1.8. This section provides that, when costs incurred under a contract entered into under Section 2.3.5.1 are not recovered through an existing Tariff provision, they will be charged to Scheduling Coordinators in proportion to their metered Demands (including exports) during the hour in which the costs are incurred.

A number of parties submitted motions to intervene, comments, and protests concerning Amendment No. 28. On May 23, 2000, the ISO submitted its Answer to Motions to Intervene, Comments, and Protests ("Amendment No. 28 Answer"). In the Amendment No. 28 Answer, the ISO recognized that a typographical error in proposed Section 2.3.5.1.8 had occurred, and committed to correct the error in a compliance filing. Amendment No. 28 Answer at 7. On June 14, 2000, the Commission issued an order accepting Amendment No. 28, and directing the ISO to submit a compliance filing to correct the error described in the Amendment No. 28 Answer, within 30 days of the

issuance of the order. *California Independent System Operator Corporation*, 91 FERC ¶ 61,256, 61,897 n.13, 61,899 (2000).
