Enclosed please find an original and fourteen copies of a report entitled *The Firm Transmission Rights Market: Review of the First Nine Months of Operation, February 1, 2000 – October 31, 2000* ("FTR Market Report") submitted by the California Independent System Operator Corporation ("ISO") in compliance with the orders issued by the Commission in this proceeding on May 3, 1999, *California Independent System Operator Corp.*, 87 FERC ¶ 61,143 (the "May 3 Order"), and August 2, 1999, *California Independent System Operator Corp.*, 88 FERC ¶ 61,156 (the "August 2 Order"). The enclosed FTR Market Report was prepared by the ISO's Department of Market Analysis ("DMA") at the request of the ISO Market Surveillance Committee ("MSC"). Also enclosed with this filing are an original and fourteen copies of a document prepared by the MSC entitled *An Assessment of the February through October 2000 California ISO* The Honorable David P. Firm Transmission Rights Market ("MSC Opinion"). The MSC Opinion addresses the FTR Market Report and provides the MSC's assessment of the initial performance of the FTR market. For reasons explained below, the ISO is also requesting that it be permitted to respond to directives in the May 3 and August 2 Orders to file proposals for modifications to the FTR market as part of its comprehensive proposal to redesign its Congestion Management system.

The ISO's proposal for initial implementation of Firm Transmission Rights ("FTRs") was filed in the above-captioned proceeding on June 30, 1998, as subsequently modified on December 4, 1998. The Commission accepted this proposal, subject to certain conditions, in the May 3 Order. These conditions included a directive that the MSC prepare a "thorough assessment of the FTR market" based on the initial release of FTRs, to be submitted to FERC by October 1, 1999. 87 FERC at 61,582. The Commission also directed the ISO to prepare proposals for a number of modifications to its FTR market by the same date. Specifically, the Commission directed that the ISO use its experience with the initial release of FTRs to develop a proposal with respect to long-term transmission rights, through either a modified FTR proposal or some other proposal. *Id.* at 61,572. The Commission also directed the ISO to FTRs and to develop a proposal to sell FTRs for all available capacity. *Id.* at 61,576.

Due to Year 2000 compliance issues and other implementation concerns, the Commission subsequently approved a revised FTR implementation schedule, under which FTRs were initially auctioned and released for the period from February 1, 2000 through March 31, 2001. August 2 Order, 88 FERC at 61,524. Consistent with this The Honorable David P. Boergers December 1, 2000 Page 3

revised implementation schedule, the Commission also ordered that the reports and proposals mandated in the May 3 Order should now be filed by December 1, 2000. *Id.*

The enclosed FTR Market Report and MSC Opinion review the first nine months of FTR market operation and are provided to comply with the Commission's directive to prepare an assessment of California's initial experience with the FTR market. The ISO has been addressing the Commission's directives that the ISO develop proposals for FTR modifications in the context of a broader Congestion Management reform process.

As the Commission is well aware, the ISO has been engaged in an extensive stakeholder process since the spring of this year concerning the redesign of the ISO's Congestion Management system.¹ The design and attributes of the FTR market are directly linked to the overall design of the ISO's Congestion Management system. Various modifications to the FTR market have therefore been developed and presented to stakeholders as part of the Congestion Management redesign process. The proposed FTR modifications that have been developed to date in that process are discussed in Section 6 of the enclosed FTR Market Report.

The Commission recently addressed the timing of the ISO's Congestion Management redesign filing in its November 1, 2000 Order Proposing Remedies for California Wholesale Electric Markets.² The November 1st Order would have the ISO complete its Congestion Management redesign effort under the guidance of a new and independent ISO Governing Board for filing by April 2, 2001. It would be premature to submit any proposals to modify the ISO's FTR market before the redesign of the Congestion Management system is finalized. Accordingly, the ISO requests that it be

permitted to respond to directives in the May 3 and August 2 Orders to file proposals for modifications to the FTR market as part of its comprehensive proposal to redesign its Congestion Management system.

The FTR Market Report is provided as Attachment A to this transmittal letter. The MSC Opinion is provided as Attachment B. Attachment C is form of notice for this filing. An electronic copy of the form of notice is provided on diskette. Also enclosed are two additional copies of this filing to be date-stamped and returned to the messenger.
