2019 Annual CRR Allocation and Auction Schedule

Listed below are the key tasks and associated dates for the 2019 Annual CRR Allocation and Auction:

- Post LT election form to CRR web page and send out ETC templates on July 6, 2018.
- OBAALSEs Source Declaration and data template due to crrdata@caiso.com on August 3, 2018.
- MSS election for MSS Operators due on August 3, 2018.
- ETC usage template due to crrdata@caiso.com on August 3, 2018.
- Initial CRR Full Network Model will be posted on August 6, 2018.
- Historical Load Submittal Window opens at 0100 on August 15, 2018 and closes at 1700 on August 21, 2018.
- Comments on CRR Full Network Model due to crrdata@caiso.com by August 17, 2018.
- Annual source/sink biddable list posted on August 24, 2018.
- Responses to comments on CRR FNM will be posted on August 29, 2018
- Incremental update to CRR FNM, if needed, will be posted on August 31, 2018.
- Seasonal Eligible Quantity (SEQ) for LSEs and OBAALSEs posted on September 5, 2018 along with source upper bound data for participating OBAALSEs.
- Priority Nomination Process (PNP) signature data and sink upper bound posted on September 6, 2018.
- Final annual CRR FNM posted with limit expansion (if applicable) and fixed CRR data on September 19, 2018
- The expiring LT election form for LT market 2020-2028 is due to crrdata@caiso.com on September 21, 2018.
- The Priority Nomination Tier (PNT) nomination window opens at 0100 on September 24, 2018 and closes at 1700 on September 26, 2018. Results of the PNT will be posted by 1700 on October 1, 2018.
- Tier LT SEQ and signature data posted on October 4, 2018.
- The Tier Long Term (LT) nomination window opens at 0100 on October 9, 2018 and closes at 1700 on October 11, 2018. Results of Tier LT will be posted by 1700 on October 16, 2018.
- Tier 2 SEQ posted on October 17, 2018
- The Tier 2 nomination window opens at 0100 on October 19, 2018 and closes at 1700 on October 23, 2018. Results of Tier 2 will be posted by 1700 on October 26, 2018.
- 2019 Annual set-aside values posted on October 30, 2018
- Tier 3 SEQ posted on October 30, 2018

- The Tier 3 nomination window opens at 0100 on November 1, 2018 and closes at 1700 on November 5, 2018. Results of Tier 3 will be posted by 1700 on November 8, 2018.
- The auction bidding window opens at 0100 on November 13, 2018 and closes at 1700 on November 15, 2018. The results of the annual auction will be posted by 1700 on November 21, 2018.
- The auction settlement amounts will be included on the invoice published on November 28, 2018 with a payment due date of December 4, 2018.
