Spring 2026 – DAME/EDAM/EDAM ISO BAA PR Update – Draft Tech Doc Proposed Plan

- Settlement functional testing is still in progress for this release due to new and modified requirement changes
- The Market Simulation will start 9/2/2025 for market functionality; for Settlements, there will be three phases of Market Simulation:
 - Phase I: Market Simulation starts from TD 9/2. The following document/information will be posted by 8/29 for Phase 1
 - Provide a Phase I list of CC completed functional testing
 - Post updated Draft Tech Docs for all impacted CC for DAME/EDAM (whole set completed functional testing and IP of testing)
 - Post Configuration Output file (whole set completed functional testing and IP of testing)
 - Start of Market Sim Structured Scenario on 9/2 Market Participants to validate settlement statement for only Phased I listed of CC completed functional testing (above list)
 - Initial Settlement statement will be published for all trade days on the Settlements calendar, but daily recalc statement will be selective and published after Phase 2. The recalc statement TD is TBD.
 - Settlements calendar will be updated



Spring 2026 – DAME/EDAM/EDAM ISO BAA PR Update – Draft Tech Doc Proposed Plan

- Phase II: by first week of October (phase II market sim start date and document posting date is TBD)
 - Provide a Phase II (include Phase I CC) list of CC completed functional testing
 - Post updated Draft Tech Docs for all impacted CC for DAME/EDAM (whole set – completed functional testing and IP of testing)
 - Post Configuration Output file (whole set completed functional testing and IP of testing)
 - Release includes break fix from phase I market sim
 - Market Participants to validate settlement statement for only Phased II listed of CC completed functional testing (above list)
 - Recalc statement will be posted with selected TD from September
 - Initial and Recalc statement will be posted for all TDs from October



Spring 2026 – DAME/EDAM/EDAM ISO BAA PR Update – Draft Tech Doc Proposed Plan

- Phase III: by Nov (phase III market sim start date and document posting date is TBD)
 - All DAME/EDAM impacted CC completed functional testing with the exception of four Transfer System Resource (TSR) Charge codes and charge codes impacted by the Congestion Revenue Allocation Initiative (CRAI).
 - We will try to include TSR charge codes in this phase but no guarantee
 - CRAI impact is still in evaluation so we might be able to include some in this phase, but we can't include all impacted charge codes to this phase. TBD.
 - Provide a Phase III list of CC completed functional testing
 - Post updated Draft Tech Docs for all impacted CC for DAME/EDAM (whole set

 completed functional testing and IP of testing)
 - Post Configuration Output file (whole set completed functional testing and IP of testing)
 - Release includes break fix from phase I and phase II market sim
 - Market Participants to validate settlement statement for all impacted CC for DAME/EDAM with the exceptions of CRAI and TSR CCs.



Spring 2026 – DAME/EDAM/EDAM ISO BAA PR – Clarification on recent CIDI tickets

- We have received several CIDI tickets regarding missing BD.
 - We are still working on functional testing
 - We will address data validation associated to CC listed on each Phase
 - Start of Market Sim 9/2 is when data validation for Phase I CC list

Unscheduled Directed Recalculations due to FERC Order

Greenleaf Energy Unit 2 LLC - FERC Filings and Settlements Overview

- December 28, 2023
 - Docket No. ER24-785-000
 - Greenleaf Energy Unit 2 LLC submitted a request to FERC to recover RAAIM penalties assessed by CAISO.
- February 26, 2025
 - Docket No. ER25-1421-000
 - Greenleaf Energy Unit 2 LLC submitted an offer of settlement to revise its RMR agreement with CAISO.
 - The settlement aimed to resolve issues related to the waiver request in Docket No. ER24-785-000.
- June 13, 2025
 - FERC approved the order to accept the proposed revisions to the RMR agreement and the resettlement of RAAIM penalties.
 - Relevant Period: July 01, 2022 Sep 10, 2023.

 - RMR Agreement Revisions:
 - Timeframe: July 10, 2023 August 31, 2023
 - Adjustments included in the T+24M Recalc Statements (already published).
- Unscheduled Directed Recalculations:
 - RMR Agreement Revisions: July 01, 2022 July 09, 2023
 - RAAIM Resettlement: July 21, 2022 September 10, 2023
 - Scheduled to be published starting from August 18, 2025, under Daily Rerun Market


