Solar VER resources exemption prior to its forecast eligibility

- A defect was found for BD RSRC_DAILY_VER_EXEMPT_FLAG during a dispute research
- Error only on **Solar** Variable Energy Resources (VER), in process of obtaining full VER classification and prior to eligibility to have forecasts
 - those already forecast eligible didn't have an issue
- This **input data issue** prevents correct application of Tariff section 40.9.2.(b)(1)(A), which exempts resources from Generic RAIM assessment, i.e. no penalties nor incentives.

Impacts

➤ **Trade Dates:**

- Fix effective date: 7/1/2023
- Resettlement TDs: 7/1/2023 through 3/16/2025
- Prod deployment fix will be correct TD 3/17/2025 onwards and will not be re-settled

➤ **Charge Codes:**

- CC 8830: Monthly RAAIM Settlement (aka RAAIM Penalty)
- CC 8831: Monthly RAAIM Allocation (aka RAAIM Incentive)
- CC 8835: Annual RAAIM Neutrality

➤ **BAA(s):**

- CISO Only

➤ **No configuration change, this is an input data only issue.**

Impacts

- Effective Date: **7/1/2023 (retro to T+21M)**
- Prod Deployment Date : **3/25/2025**
- This issue does not trigger every month
- Settlement run impacts:

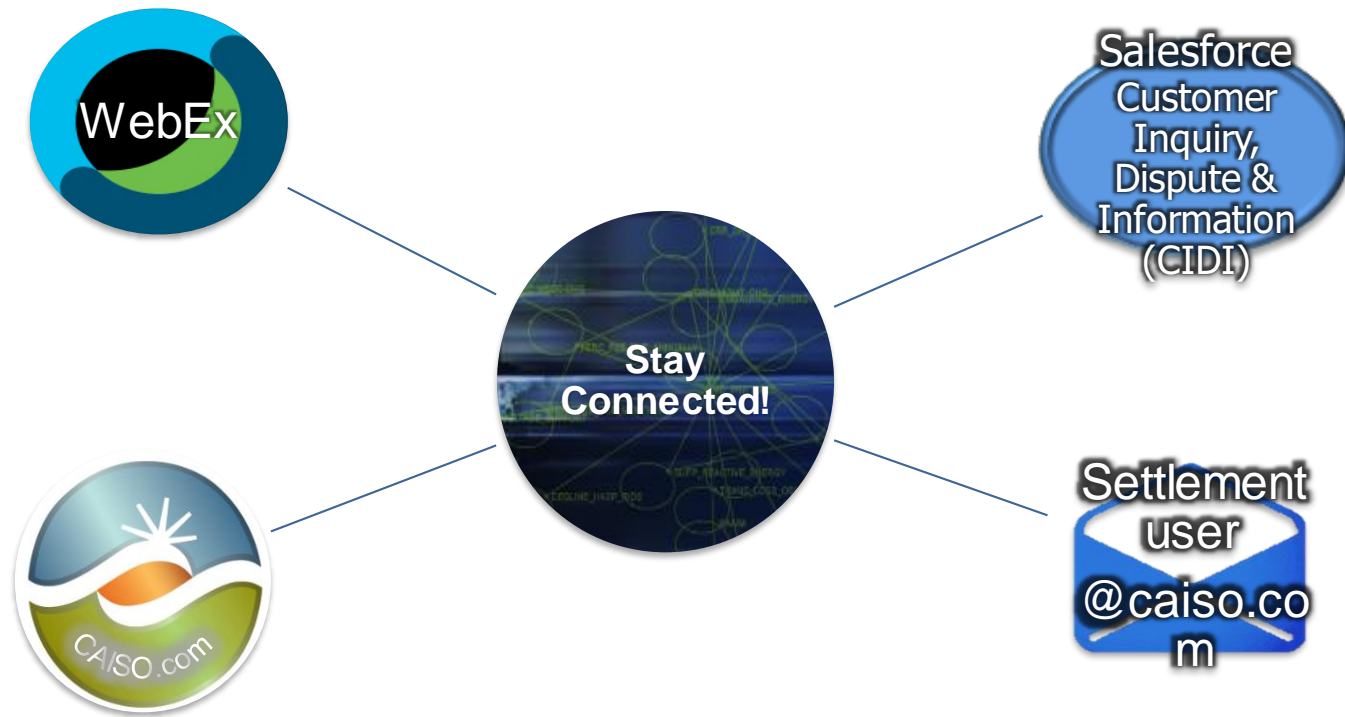
Additional Notes

- Since RAAIM is a monthly Charge Code, in order to get fully accurate monthly values, all dailies of the month should have captured the correct input BD mapping values
 - E.g. The T+11M only fixes from May 6, 2024 towards end of month, and leaves May 1-May 5, 2024 incorrect. So the full May 2024 monthly will have accurate settlement only at T+21M.
- Resettlement to refund generic exemption for these resources will impact generic incentive pool in CC 8831
 - i.e. Other resources/SCs that had generic incentive for the impacted month(s) could also have re-settlement due to this issue.
