



- Resolves a design gap from Intertie Deviation Settlement project
- Directly impacts CC 6456
- Issue: calculating a deviation and charging penalty (**CISO BAA only**) in cases of HASP market disruption
- Solution: New disruption flag BD + formula update to exempt hours where HASP market disruption occurs (flag = 1)
- Implementation Plan
 - Before fall to ensure corrections make T+70 statement instances
 - Functional testing wrapping up
 - Planning internal UAT
 - Draft config output file posting + PRR outlining BPM changes: **dates TBD**
 - Target 8/18 prod deployment is subject to change, dependent on testing
 - Watch for additional SUG communications

ESDER Phase 4 Initiative Overview

- Changes to Real Time Net Amount PC
 - Allowing End-Of-Hour (EOH) State-of-charge (SOC) biddable parameter in RTM.
 - RTM Bid Cost Recovery (BCR) flagged to account for:
 - EOH SOC
 - RT Self-schedules
- If MSOC and EOH SOC Parameter exists in the same interval, BCR shall follow EOH SOC Parameter rules below.
- System will evaluate RTM Bid Cost Shortfall/Surplus for the previous and current hour from above flags for non-REM LESRs, as follows:
 - If RTM Bid Cost is $>$ RTM Market Revenue (shortfall):
 - this interval shall be set to 0 in the daily BCR settlements;
 - If RTM Bid Cost is \leq RTM Market Revenue (surplus): there shall be no change in this interval
- These surpluses shall be included in the daily BCR settlements and used to cover shortfalls that may have been generated in other periods in the day.

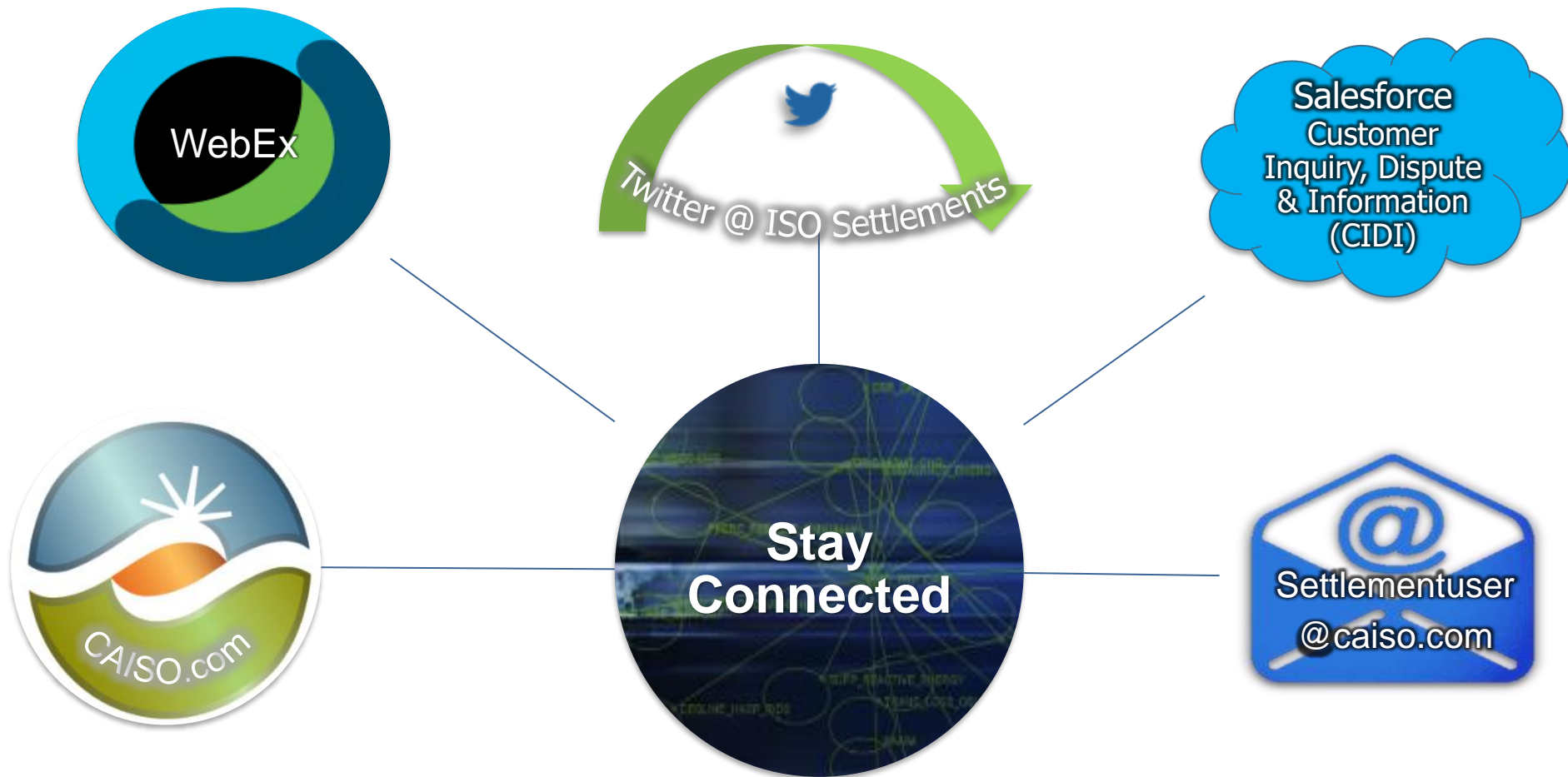

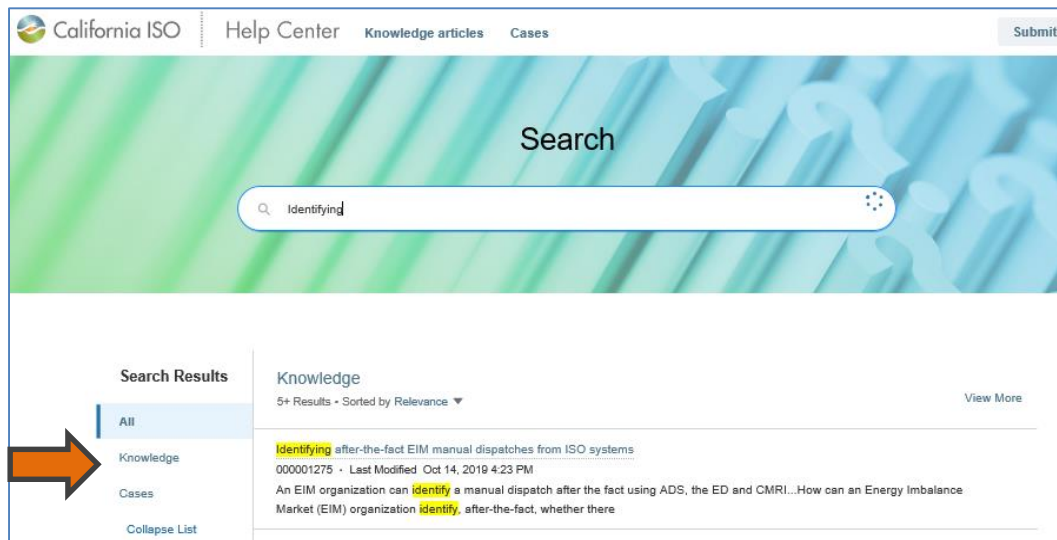
