Publication of Unscheduled Reissue Recalculation Settlement Statements

- The ISO published an unscheduled reissue recalculation settlement statements under run type Daily Rerun Market for trading date March 25, 2019 on October 14, 2020.
- Posted as Version 3 in MRI – S.
- The T+18M statement posted on September 28, 2020 contained a processing error.
- The statements will reflect a correction to the Nonrefundable Interconnection Funds. The allocation of the Nonrefundable Interconnection Funds is in accordance with the CAISO Tariff 37.9.4 - per the April 15, 2020 Market Notice (<http://www.caiso.com/Documents/FERCAppealISORequest-DistributePenaltyProceeds-NonrefundableInterconnectionFunds041520.html#search=non%2Drefundable>) and FERC's order to distribute the Nonrefundable Interconnection Funds (<http://www.caiso.com/Documents/Mar6-2020-LetterOrder-PetitionforApproval-Disbursements-ER20-179.pdf>).
