





# NERC/WECC Invoice

- The ISO published preliminary NERC/WECC statements and invoices for 2022 NERC/WECC charges to the Market Results Interface-Settlements (MRI-S) and the Secure File Transfer Protocol (SFTP) server on August 20, 2021. The charges for assessment year 2022 appear on the NERC/WECC initial statement under charge code (CC) 6490, with January 1, 2020 as the trade date.
- The preliminary NERC/WECC charge rate for assessment year 2022 is provided below for scheduling coordinators' information pursuant to ISO Tariff section 11.20.4.

## NERC/WECC Invoice (cont.)

- Payments for the preliminary NERC/WECC charges are due by 10:00 a.m. (Pacific Time) on September 19, 2021, pursuant to ISO Tariff section 11.20.5.
  - Market participants should be aware that, because September 19 falls on a Sunday, it will be difficult to send payment to the ISO on that date. Moreover, payments received on September 20 or later will be considered late under the Tariff section 11.20.5. Therefore, the ISO recommends that market participants plan to submit payments no later than Friday, September 17, which is the final business day before the payment deadline.
- On June 7, 2021, the ISO posted NERC/WECC information files to the MRI-S and the SFTP server in accordance with the approved tariff provisions for review by scheduling coordinators.

# Adjustment of Amendment 60 Interest and GFN Distribution

- On April 30, 2021, the ISO previously published settlements statements and invoices that reflected interest through April 30, 2021 for Amendment 60.
- As noted on a call held on July 21, 2021 (see link below for presentation discussed on the July 21 call) additional settlement adjustment are required for:
  - Correcting errors in the interest calculations for March 2005 for startup costs and October 2007 for minimum load cost
  - Unwind incorrect distribution of California Oregon Transmission Project Agreement funds
    - Reallocation of payments and charges for use of COTP Transmission (July – December 2004)
  - Distribution of funds from a separate GFN (reflected on the daily historical initial statement for trade date, March 02, 2009)
  - As discussed on the July 21, 2021 call, the ISO will be calculated incremental interest on the April 30, 2021 and September 17, 2021 invoices

# Adjustment of Amendment 60 Interest and GFN Distribution (cont.)

- The ISO will publish the historical statements and invoices for Amendment 60 and Reliability Capacity Services Tariff (RCST) to the MRI-S and SFTP server on September 17, 2021.




