On February 16, 2024, California Independent System Operator Corporation (CAISO) submitted revisions to its Tariff to add and modify provisions effectuating CAISO's day-ahead market enhancements and extended day-ahead market, in compliance with the directives in a December 20, 2023 Commission order.¹ The tariff revisions are in satisfactory compliance with the December 2023 Order. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – West under 18 C.F.R. § 375.307, the revisions are accepted for filing, effective as requested.² For tariff revisions with a December 31, 9998 effective date, CAISO must notify the Commission of the effective date of the tariff revisions within five business days of their implementation in an eTariff submittal.³

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed document(s); nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against CAISO.
