**REQUEST FOR EXTENSION OF TIME OF THE
CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION**

Pursuant to Rule 212 of the Federal Energy Regulatory Commission's ("Commission") Rules of Practice and Procedure, 18 C.F.R. § 385.212 (2007), the California Independent System Operator Corporation ("CAISO")¹ submits this request for a six business day extension of time to answer the comments of the State Water Contractors and the Metropolitan Water District of Southern California ("SWC/MWD") concerning the CAISO's Thirty-Third Status Report on Re-run Activity, as filed in the above-referenced dockets on April 6, 2007. Under the Commission's rules, the

CAISO's answer to SWC/MWD's comments would be due on April 23, 2007. However, for the reasons set forth below, the ISO is requesting a six business day extension in order to answer these comments on May 1, 2007.

SWC/MWD's comments are limited to addressing the CAISO's proposal, as set forth in its Thirty-Third Status Report on Re-run Activity, to calculate and reflect interest on adjustments made during the preparatory rerun for transactions that took place during the "Refund Period" (*i.e.* October 2, 2000 through June 20, 2001). SWC/MWD takes issue with the CAISO's proposal for several reasons.

As indicated in the Thirty-Fourth Status Report on Re-Run Activity, the CAISO made available to parties data concerning preparatory rerun interest calculations on March 29, 2007, and indicated that it would accept comments from parties on these calculations through April 19. The CAISO believes that it would be most efficient, in terms of its own resources as well as those of the Commission, to respond to all comments addressing the preparatory rerun interest issue, including the comments submitted by SWC/MWD, on one date, after it has had the opportunity to review all such comments. Therefore, the CAISO respectfully requests that the Commission grant it a six business day extension of time in order to answer SWC/MWD, as well as any other parties that provide comments on the preparatory rerun interest issue, on May 1, 2006.

No party should be prejudiced as a result of the Commission granting this brief extension. The CAISO has spoken to counsel for SWC/MWD who informed the CAISO that SWC/MWD did not oppose this request for extension. For these reasons, the CAISO respectfully requests that the Commission grant it a six business day extension to submit its answer to SWC/MWD.
