On January 17, 2023, the California Independent System Operator Corporation (CAISO) submitted changes to the Transmission Control Agreement (TCA) among the CAISO and the current participating transmission owners to include a new participating transmission owner, Citizens S-Line Transmission LLC, and to make minor additional changes. The CAISO requested an effective date of these changes on April 15, 2023, with the possibility of submitting a compliance filing to revise the effective date, if other than that date. By order issued April 14, 2023, the Commission accepted these changes and directed the CAISO to submit a compliance filing to inform the Commission of the revised effective date within thirty (30) business days of the in-service date.<sup>1</sup>

The actual in-service date of the Citizens S-Line entitlement was July 1, 2024. Accordingly, the CAISO is submitting this compliance filing to revise the effective date of the TCA changes from April 15, 2023 to July 1, 2024.<sup>2</sup>
