#### **Project Summary:**

In an effort towards continuous improvement in the New Resource Implementation Process, the California ISO has continuous work on multiple enhancements to the Resource Interconnection Management System (RIMS). These are released in groups or batches to reduce errors and real time impact. The Spring 2025 group is one of these batches and release has been combined with the RIMS Enhancements needed for FERC Order 2222.

#### **Project Summary**


The California ISO amended its existing Distributed Energy Resource (DER) policy to accommodate FERC Order 2222, which included reducing the maximum capacity requirement and introducing a new Masterfile Distributed Energy Resource Aggregation (DERA) resource type, Heterogeneous Distributed Energy Resource Aggregation (HDERA).

In support of this effort, the California ISO is also moving DERA/HDERA Projects into the RIMS MPAI Module and adding fields specific to DERA/HDERA Projects. For more project information: <u>FERC Order 2222 Release Planning</u>

    - 3.4.3.1 Project Types Affected: Existing QF, Wind QF, Pseudo (Existing **not** New Construction), Dynamic (Existing **not** New Construction). All other Project Types remain unchanged.
    - 3.4.3.2 NOTE<sup>3</sup>: We are aware of some errors in this 3.4.1 update. We are currently working on the fix. **Interim Solution while fix IS IN PROGRESS:** 
      - Create new projects with Normal FNM Schedule conditions:
        - a. Implementation Date = Open FNM Model Build's Earliest Implementation Date
        - b. COD Date >= (Implementation Date + 5 days)
      - 2. Once project is created
