Informational Filing of Effective Date of Variable Operations and Maintenance Adders Tariff Amendment

Dear Secretary Bose:

On September 28, 2023, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to implement tariff revisions arising from its triennial variable operations and maintenance initiative, which assess whether it is appropriate to update the current default Variable Operations and Maintenance (VOM) Adders. By order issued November 21, 2023, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO implemented the tariff changes for the triennial variable operations and maintenance initiative on December 1, 2023. Accordingly, the CAISO is submitting this informational filing to specify an effective date of December 1, 2023 for the tariff revisions accepted by the Commission in this docket.²

¹ Letter Order in Docket No. ER23-2956-000 (2023). The Commission directed the CAISO to notify the Commission of the actual effective date of the Tariff revisions within five business days of their implementation, in an eTariff submittal using Type of Filing Code 150 – Report.

² Specifically, this informational filing updates the effective date for all Tariff Records submitted in the initial filing on September 28, 2023. The CAISO is submitting the informational filing in eTariff using Type of Filing Code 150.
