**EXPEDITED JOINT MOTION OF THE CALIFORNIA  
INDEPENDENT SYSTEM OPERATOR AND THE  
PARTICIPATING TRANSMISSION OWNERS FOR AN  
EXTENSION OF TIME TO FILE COMPLIANCE FILINGS**

Pursuant to Rule 212 of the Federal Energy Regulatory Commission (FERC or Commission) Rules of Practice and Procedure, 18 C.F.R. § 385.212 (2004), the California Independent System Operator Corporation (ISO) and the Participating Transmission Owners (Pacific Gas and Electric Company, San Diego Gas & Electric

Company, and Southern California Edison Company) (collectively, the Filing Parties) hereby file this Motion for Extension of Time to File Compliance Filings to request that the due date of the compliance filings required by the recent orders issued in Docket Nos. RM02-1-006 and RM05-4-000, as described in the body of this Motion, be extended for the Filing Parties from August 15, 2005 to August 30, 2005.

## **I. MOTION FOR EXTENSION OF TIME**

On June 2, 2005, the Commission issued its Final Rule on Interconnection for Wind Energy in docket No. RM05-4-000 (Wind Final Rule).<sup>1</sup> Pursuant to the Wind Final Rule, the Filing Parties are required to adopt the Final Rule Appendix G as an amendment to their Large Generator Interconnection Agreement by August 15, 2005, which is 60 days after publication of the Wind Final Rule in the *Federal Register*.<sup>2</sup> On June 16, 2005, the Commission issued Order No. 2003-C,<sup>3</sup> which affirmed, with certain clarifications, Order No. 2003-B. Pursuant to Order No. 2003-C, the Filing Parties must submit another compliance filing on August 15, 2005, or 60 days after issuance of Order No. 2003-C.<sup>4</sup> Finally, on July 1, 2005, the Commission issued its “Order Accepting in Part and Rejecting in Part Order Nos. 2003, 2003-A, and 2003-B Compliance Filings,” (Compliance Filing Order),<sup>5</sup> which requires the Filing Parties to submit a compliance

filing that includes the modifications discussed in the Compliance Filing Order by August 30, 2005.<sup>6</sup>

Because the Commission orders discussed in the preceding paragraph obligate the Filing Parties to make three compliance filings modifying the same set of documents, the Filing Parties believe that it would be more efficient to make one filing – rather than three separate filings – to comply with such orders. The Filing Parties imagine that all parties, including the Commission and any Interconnection Customers attempting to view the proposed interconnection procedures for the ISO control area on the Commission’s website, will benefit from this short extension of time so that one set of documents can be created and filed to comply with all three orders. Because each of these filings will take substantial time and coordination among the Filing Parties, the Filing Parties request that the Commission grant the Filing Parties a fifteen-day extension on the Wind Final Rule and Order No. 2003-C compliance filings. The Commission’s grant of this short extension of time will not prejudice any party to the proceedings. By this Motion, the Filing Parties also seek confirmation from the Commission that it agrees that it would be more efficient for the Filing Parties to comply with the Wind Final Rule, Order No. 2003-C and the Compliance Filing Order by making one filing, rather than three.

## **II. CONCLUSION**

For the foregoing reasons, the Commission should grant this Expedited Joint Motion of the California Independent System Operator and the Participating Transmission Owners for an Extension of Time to File Compliance Filings.
