**INFORMATIONAL FILING REGARDING ISSUANCE OF MARKET NOTICE
IN CONNECTION WITH PETITION FOR
DISTRIBUTION OF FORFEITED FUNDS**

The California Independent System Operator Corporation (“ISO”) submits this informational filing to provide the Commission with official notice that it has issued a market notice of its December 11, 2012 petition in the above-captioned docket.¹ On December 11, 2012, the ISO made a filing in the above-captioned proceeding seeking Commission approval to distribute funds forfeited by interconnection customers that withdrew from the ISO’s generation interconnection queue during calendar year 2011. As explained in that filing, per the terms of the ISO’s tariff, these forfeited funds are allocated to the ISO’s market participants at the end of each calendar year.²

The ISO tariff requires the ISO to obtain Commission approval of its allocation determination before distributing the forfeited funds. Attachment A to the December 11 filing identifies the ISO’s proposed distribution of the funds forfeited by interconnection customers during calendar year 2011.

In the December 11 filing, the ISO indicated, it would issue a market notice of this filing to its participants.³ Due to an administrative oversight, the ISO did not issue a market notice contemporaneously with the December 11 filing. The ISO recently discovered this oversight and issued a market notice of the December 11 filing on February 8, 2013.⁴
