Dear Secretary Bose:

On July 9, 2020, the California Independent System Operator Corporation (CAISO) filed a tariff amendment to enable updates to default commitment cost and default energy bids (CCDEBE). By order issued September 21, 2020, the Commission accepted this tariff amendment and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO implemented CCDEBE on February 15, 2021 for Trading Date February 16. Accordingly, the CAISO is submitting this informational filing to specify an effective date of February 15, 2021 for the tariff revisions accepted by the Commission in this docket.²
