**Informational Filing of Effective Date of Hybrid Resources and
Co-located Resources**

Dear Secretary Bose:

On September 8, 2021, the California Independent System Operator Corporation (CAISO) filed tariff revisions to clarify market rules for hybrid and co-located resources, specifically to (1) enhance market participation by hybrid and co-located resources, and (2) allow the use of multiple aggregate capability constraints by co-located resources at a single generative facility. By order issued November 30, 2021, the Commission accepted this tariff amendment and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The majority of the CAISO's tariff revisions took effect on December 15, 2021 and the CAISO submitted an informational filing regarding the effective date for those provisions on December 16, 2021. The remaining tariff revisions relating to dynamic limit functionality for hybrid resources took effect on February 1, 2023. Accordingly, the
