Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO) submits this notification to inform the Commission of the actual effective date of tariff revisions accepted by the Commission in its order issued in the captioned proceeding on January 21, 2020,<sup>1</sup> regarding proposals included in the Commitment Costs and Default Energy Bid Enhancements (CCDEBE) tariff amendment the CAISO filed on August 30, 2019.

Pursuant to the directive in Ordering Paragraph (B) of the January 21 Order, the CAISO hereby notifies the Commission that the actual effective date of the tariff revisions accepted by the Commission is January 28, 2020. The CAISO respectfully requests that the Commission update the effective date of the relevant eTariff records, which were filed in the CCDEBE tariff amendment with an indefinite effective date, to January 28, 2020.<sup>2</sup>
