Pursuant to Rule 213 of the Federal Energy Regulatory Commission's ("Commission") Rules of Practice and Procedure, 18 C.F.R. § 385.213 (2006), the California Independent System Operator Corporation ("CAISO")¹ hereby moves for leave to file one day out of time its filing in compliance with the Commission's December 14, 2007, "Order Conditionally Accepting and Suspending, Subject to Modifications, Tariff Revisions and Directing Compliance Filing," 121 FERC ¶ 61,258 (2007) ("December 14 Order"). The compliance filing in the above-referenced docket is being filed concurrently with the instant motion.

On October 16, 2007, the CAISO proposed to incorporate resource adequacy provisions related to its Market Redesign and Technology Upgrade ("MRTU") project into its currently effective CAISO Tariff ("Early Effectiveness Amendments"). The December 14 Order conditionally accepted the Early Effectiveness Amendments, but required the CAISO to submit a compliance filing within 30 days to incorporate specific modifications. The 30 day compliance deadline was January 14, 2008. The CAISO, however, inadvertently calendared the due date to be January 15, 2008.

¹ Capitalized terms not otherwise defined herein are used in the sense given in the Master Definitions Supplement, Appendix A to the MRTU Tariff.

No party will suffer any prejudice by permitting the CAISO to submit its compliance filing one day late. Rather, participants in the CAISO market will benefit from the incorporation into the CAISO Tariff of the modifications directed by the Commission in its December 14 Order. Accordingly, the CAISO respectfully requests that the Commission accept the concurrently submitted compliance filing one day out of time.
