Implement Pathways Step 1 Proposal**

Dear Secretary Reese:

On November 22, 2024, the California Independent System Operator Corporation (CAISO) filed amendments to the provision of its tariff that governs regulatory filings to implement the “Pathways Step 1” proposal. By order issued April 2, 2025, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to notify the Commission of the actual effective date no less than seven (7) days prior to the date of implementation.¹

The CAISO plans to implement these tariff amendments on Monday, July 8, 2025, which is before the next meeting of the CAISO Board of Governors and Western Energy Markets (WEM) Governing Body, scheduled to begin on July 22. Accordingly, the CAISO is submitting this informational filing to specify this planned effective date of July 8, 2025 for the tariff revisions accepted by the Commission in this docket.²
