Dear Secretary Reese:

The California Independent System Operator Corporation (CAISO) submits this informational report on the CAISO's generator interconnection queue cluster 15.1 This report fulfills the requirement in California Independent System Operator Corp., 188 FERC ¶ 61,225 (2024).² There, the Commission directed the CAISO to submit informational reports for clusters 15 and 16 detailing, providing for each of the four sets of study criteria:3

- 1. the MW of interconnection capacity that has qualified for the cluster study;
- the number of proposed generating facilities that have qualified for the cluster 2. studv: and
- 3. the number of interconnection requests and MW of interconnection capacity that have qualified for the cluster study by fuel type, including which requests are partially deliverable resources.4

Capitalized terms not otherwise defined herein have the meanings set forth in appendix A to the CAISO tariff, and references to specific tariff sections and appendices are references to sections and appendices in the existing CAISO tariff unless otherwise specified.

See Section 4 of Appendix KK to the CAISO tariff. The four sets of criteria are interconnection requests (1) seeking deliverability in deliverable zones, (2) seeking deliverability in merchant zones, (3) Energy Only with cash reimbursement, and (4) Energy Only without cash reimbursement.

ld. Per the Commission's order, the data submitted in this report is based on the commencement of the cluster study, and does not account for any withdrawals since, if any.

The CAISO includes all data below. The CAISO also published a comprehensive analysis of the scoring criteria in cluster 15, and determined that the scoring criteria were successful in identifying first-ready projects.⁵ The CAISO also actively maintains data on the composition of each queue cluster on the CAISO website.⁶
