Evaluation Enhancements Tariff Amendment**

Dear Secretary Bose:

On March 31, 2023, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to implement market rule changes developed through phase 2 of its resource sufficiency evaluation (RSE) enhancements stakeholder initiative and related clarifications to interaction of the RSE and the CAISO's Flexible Ramping Product (FRP). By order issued May 31, 2023, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO implemented the tariff changes for RSE enhancements initiative on July 1, 2023. Accordingly, the CAISO is submitting this informational filing to specify an effective date of July 1, 2023 for the tariff revisions accepted by the Commission in this docket.
