**Informational Filing of Effective Date of Capacity Procurement
Mechanism Soft Offer Cap Tariff Amendment**

Dear Secretary Reese:

On February 9, 2024, the California Independent System Operator Corporation (CAISO) submitted a tariff amendment to propose a straightforward update to the level of the capacity procurement mechanism (CPM) soft offer cap. By order issued April 25, 2024, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO implemented the tariff changes pertaining to the capacity procurement mechanism soft offer cap update on June 1, 2024. Accordingly, the CAISO is submitting this informational filing to specify an effective date of June 1, 2024 for the tariff revisions accepted by the Commission in this docket.²
