Dear Secretary Bose:

On December 12, 2022, the California Independent System Operator Corporation (CAISO) submitted a filing to amend several sections of the CAISO tariff, including a clarification to Section 30.11.5. The CAISO requested an effective date of February 5, 2023 for all of the revisions except for the clarification to Section 30.11.5. The CAISO indicated it would submit an informational filing to notify the Commission of the actual effective date of the amendment to Section 30.11.5 within five (5) business days of implementation. By order issued February 7, 2023, the Commission accepted these tariff amendments, effective as requested.<sup>1</sup>

The CAISO implemented the revision to Section 30.11.5 on June 21, 2023. Accordingly, the CAISO is submitting this informational filing to specify an effective date of June 21, 2023 for the revisions to that section accepted by the Commission in this docket.<sup>2</sup>
