Dear Secretary Bose:

The California Independent System Operator Corporation (“CAISO”) submits this filing in compliance with the Commission’s May 31, 2016, order issued in this proceeding.<sup>1</sup>

## **I. Background and Discussion**

The May 31 order accepted the CAISO’s May 17, 2016, request for a limited waiver of tariff provisions necessary to allow a delay in the implementation of phase 1A of the two-phase reliability services initiative (RSI). The CAISO has sought several delays to implementation, the most recent of which was presented in the May 17 filing. The May 31 order approved a delay until November 1, 2016, subject to the condition that the CAISO file revised tariff records to reflect the new implementation date.<sup>2</sup>

The CAISO hereby submits this compliance filing consistent with the Commission’s directive. Specifically, all tariff revisions accepted by the Commission in its October 1, 2015, order in this proceeding,<sup>3</sup> with the exception of sections 40.2.4, 40.10.5.1(a), and 40.10.5.1.1, will now have an effective date of November 1, 2016.
