Informational Filing of Effective Date of Transmission Control Agreement – LS Power

Docket No. ER25-169-____

Dear Secretary Reese:

On October 21, 2024, the California Independent System Operator Corporation (CAISO) proposed changes to the Transmission Control Agreement (TCA) among the CAISO and the current Participating Transmission Owners (Participating TOs) to: (1) update the TCA to reflect the Subscriber Participating TO provisions of the CAISO tariff previously approved by the Commission; (2) include SunZia Transmission, LLC (SunZia) as a new Participating TO that will follow the Subscriber Participating TO model; (3) include LS Power Grid California, LLC (LSPGC) as a new Participating TO; and (4) make minor clean-up changes. By letter order issued December 13, 2024, the Commission accepted revisions to the TCA effective as listed in the attached Appendix to the order, with the majority of tariff records taking effect on December 21, 2024, and the remaining tariff records taking effect on a to be determined future date.¹ As stated in the initial filing on October 21, 2024, the CAISO pledged to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation for both the tariff records related to SunZia and LSPGC individually.

The Commission directed the CAISO to notify the Commission of the actual effective date of the Tariff revisions within five business days of their implementation, in an eTariff submittal using Type of Filing Code 150 – Report.

As operational control of the LSPGC project took place on March 12, 2025, the CAISO is submitting this informational filing to specify an effective date of March 12, 2025 for the tariff records related to LSPGC accepted by the Commission in this docket.² The tariff records related to SunZia are still pending. The CAISO will submit an informational filing for their effective date within 5 business days after the CAISO assumes operational control of the SunZia project.

The CAISO has served copies of this filing on all the parties to the service list for this proceeding. In addition, the CAISO is posting this filing on the CAISO website.
