Dear Secretary Salas:

In response to the Federal Energy Regulatory Commission's ("Commission") February 24, 2006 Order Approving Tariff Revisions ("February 24 Order") issued in the above-referenced docket, enclosed for filing please find the California Independent System Operator Corporation's ("CAISO") Simplified and Reorganized ("S&R") Tariff conformed through March 6, 2006. Although the February 24 Order did not specifically direct the CAISO to file a conformed tariff, the CAISO believes it will be helpful to the Commission and to stakeholders to make this conformed S&R Tariff available in its entirety.¹ More specifically, the S&R Tariff as filed on September 22, 2005 has been conformed to incorporate:

- (1) changes agreed to in the CAISO's November 4, 2005 Answer to Protests, Motions to Intervene, and Comments² and accepted by the Commission in its February 24 Order;

² This filing also corrects a minor error in Attachment B to the CAISO's November 4, 2005 Answer in this Docket, which mistakenly listed the effective date for pre-S&R Tariff Section 2.2.9, now S&R Tariff Section 30.3.5, as effective "Upon the date the ISO implements changes to its scheduling system to permit Section 2.2.9 of the ISO Tariff to go into effect." In fact, the software that pertains to Section 2.2.9 was tested and functional on January 1, 2005. Accordingly, the clean S&R Tariff sheets in Attachment A to this filing accurately reflect an effective date of "March 1, 2006" for Section 30.3.5.
