NOTICE ESTABLISHING DUE DATE FOR COMMENTS
AND ELECTRONIC SERVICE OPTION

(May 12, 2004)

The Federal Energy Regulatory Commission is seeking comments from interested participants in response to the Comments of the California Independent System Operator Corporation regarding Technical Conference filed by the California Independent System Operator Corporation (CAISO) on May 11, 2004 in this docket.

Interested participants are invited to submit information and comments in response to the CAISO's filing by no later than 5:00pm (EST) on Wednesday, May 19, 2004.

Interested participants will have the option of serving their comments on other participants by means of an electronic list established by the Federal Energy Regulatory Commission. To choose this option, the instructions set out in the attachment to this Notice must be followed.

Please note that use of the electronic service option does not relieve any participant of the requirement to:

1. file comments or other submissions in this docket with the Commission in accordance with filing procedures; and
2. serve participants who are not registered on the electronic list.

The electronic list is intended to reduce the time and expense associated with service of documents on participants in this proceeding.

ESTABLISHMENT OF MD02 LIST SERVE

Participants who file comments and information relating to the California Independent System Operator Corporation MD02 proceeding in docket number ER02-1656-017 may elect to receive service of documents from other interested participants by means of an electronic “List Serve” that has been established by the Commission for this purpose. The following information describes how this can be done.

1. File document with the Federal Energy Regulatory Commission in the usual way. The document, once filed, will appear in the Commission’s e-Library.
2. If the participant wishes to receive service in this proceeding by electronic means, a representative for the participant must first register the participant for inclusion in the List Serve process, by sending an e-mail to the List Serve Administrator, as follows:
 - a. Address the e-mail to listserv@lists.ferc.gov.
 - b. The subject matter/heading should state “ER02-1656-017”.
 - c. The body of the e-mail should contain **only** the following:

SUBSCRIBE ER02-1656-017 firstname lastname companyname

The representative’s first and last name should replace “firstname” and “lastname”, respectively. The name of the company being represented should replace “companyname”, with all spaces in the company’s name omitted.

3. Once approved, each participant will receive a reply e-mail containing instructions about how to use the List Serve. These instructions will confirm that each time a document is submitted to the List Serve by the participant, all other registered participants will also receive that document, thus relieving the participant of the obligation to serve hard copies of their document on those other registered participants. The instructions will also include details of how to leave the List Serve and how to determine which other participants are registered to receive electronic service.

It is intended that the List Serve process will be used as a substitute for service of MD02 documents filed with the Commission by participants. This process has been

established by the Commission at the request of participants, to reduce the significant cost and time involved in effecting service of documents on other participants in this proceeding. The List Serve process does not relieve any participant of the obligation to file documents with the Commission according to the usual filing procedures, or to serve participants who are not registered as part of the List Serve.
