On March 18, 2026, the California Independent System Operator Corporation (CAISO) submitted a Certificate of Concurrence<sup>1</sup> to the Affected Participating Transmission Owner Upgrade Facilities Agreement between Southern California Edison Company, Olympus Phase 1, LLC, Olympus Phase 2, LLC and Olympus Phase 3, LLC, and CAISO.<sup>2</sup> CAISO requests that the submittal be accepted effective January 14, 2026. Pursuant to authority delegated to the Director, Division of Electric Power Regulation – West, under 18 C.F.R. § 375.307, the submittal is accepted, effective January 14, 2026, as requested.<sup>3</sup>

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission’s regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.

This action does not constitute approval of any service, rate, charge, classification, or any rule, regulation, contract, or practice affecting such rate or service provided for in the filed documents; nor shall such action be deemed as recognition of any claimed contractual right or obligation affecting or relating to such service or rate; and such action is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against applicant(s).
