1.	Is Convergence Bidding not included in rate extension?	Jackie DeRosa	Judy Sanders	Convergence Bidding is being added to the tariff through a different Stakeholder process therefore in 2011 rates will be included in the budget/GMC process
2.	FERC approved MUFE – Adjustment or fallout?	Sean Neil	Judy Sanders	MUFE went into effect June 1 due to Dec 30 FERC order. Settlement happened after that & resulted in same rate structure
