II. BACKGROUND

On March 24, 2005, Southern California Edison (SCE) filed a Petition for Declaratory Order concerning transmission facilities in the Antelope Valley/Tehachapi region of California.

By its Notice issued April 4, 2005, the Commission established April 14, 2005, as the date motions to intervene are to be filed in the above-captioned proceeding.

III. BASIS FOR MOTION TO INTERVENE

The ISO is a non-profit public benefit corporation organized under the laws of the State of California and responsible for the reliable operation of a grid comprising the transmission systems of Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company, Trans-Elect NTD Path 15 LLC, Western Area Power Administration - Sierra Nevada Region and the Cities of Vernon, Anaheim, Azusa, Banning Riverside

and Pasadena, California. As the operator of this grid, the ISO believes that it has a unique interest in any Commission proceeding concerning the issues raised in the captioned proceeding.
