II. BACKGROUND

On December 24, 2003, Southern California Edison Company (SCE) tendered for filing revisions to its Transmission Owner Tariff (TO Tariff), FERC Electric Tariff, Second Revised Volume No. 6, Appendices I, II and III, to reflect the change in transmission rates resulting from the annual update of the Transmission Revenue Balancing Account Adjustment.

By its Notice issued January 5, 2004, the Commission established January 14, 2004 as the date motions to intervene are to be filed in the above-captioned proceeding


III. BASIS FOR MOTION TO INTERVENE
