**MOTION TO INTERVENE OF THE

## II. BACKGROUND

On December 28, 2004, San Diego Gas & Electric Company (SDG&E) tendered for filing a change in rate for the Transmission Revenue Balancing Account Adjustment and its Transmission Access Charge Balancing Account Adjustment as set forth in its Transmission Owner Tariff. SDG&E states that the effort of the rate change is to increase rates for jurisdictional transmission service utilizing that portion of the California ISO –controlled grid owned by SDG&E. SDG&E requests an effective date of January 1, 2005.

By its Notice issued January 7, 2005, the Commission established January 18, 2005, as the date motions to intervene are to be filed in the above-captioned proceeding.

## III. BASIS FOR MOTION TO INTERVENE

The ISO is a non-profit public benefit corporation organized under the laws of the State of California and responsible for the reliable operation of a grid

comprising the transmission systems of Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company, Trans-Elect NTD Path 15 LLC, Western Area Power Administration - Sierra Nevada Region and the Cities of Vernon, Anaheim, Azusa, Banning Riverside and Pasadena, California. As the operator of this grid, the ISO believes that it has a unique interest in any Commission proceeding concerning the issues raised in the captioned proceeding.

#### **IV. CONCLUSION**

For the foregoing reasons, the ISO respectfully requests that the Commission permit it to intervene, and that the ISO be accorded full party status in this proceeding.
