**MOTION TO INTERVENE ONE DAY OUT-OF-TIME OF THE
CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION**

II. BACKGROUND

On November 2, 2004, Southern California Edison (SCE) submitted for filing the following agreements between SCE and State of California Department of Water Resources (CDWR) under FERC Electric Tariff, Second Revised Volume No. 6: Edmonston Pumping Plant Interconnection Facilities Agreement, Service Agreement No. 31; Pearblossom Pumping Plant Interconnection Facilities Agreement, Service Agreement No. 32; Oso Pumping Plant Interconnection Facilities Agreement, Service Agreement No. 33; William E. Warne Power Plant Interconnection Facilities Agreement, Service Agreement No. 34; and Alamo Power Plant Interconnection Facilities Agreement, Service Agreement No. 35. SCE also submitted the Devil Canyon Service Agreement for Wholesale Distribution Service, Service Agreement No. 126, under FERC Electric Tariff, First Revised Volume No. 5. SCE requests an effective date of January 1, 2005.

¹ In addition to Mr. Ivancovich and Mr. Rubin, the ISO respectfully requests that Ms. Le Vine be included in the Official Service List. Mr. Ivancovich and Ms. Le Vine work in separate buildings, and it would be of significant assistance to the ISO if both were included on the list.

By its Notice issued November 10, 2004, the Commission established November 23, 2004, as the date motions to intervene are to be filed in the above-captioned proceeding.

III. BASIS FOR MOTION TO INTERVENE

The ISO is a non-profit public benefit corporation organized under the laws of the State of California and responsible for the reliable operation of a grid comprising the transmission systems of PG&E, Southern California Edison Company, San Diego Gas & Electric Company and the Cities of Vernon, Anaheim, Azusa, Banning and Riverside, California. As the operator of this grid, the ISO believes that it has a unique interest in any Commission proceeding concerning the issues raised in the captioned proceeding.

III. MOTION TO INTERVENE OUT OF TIME

Due to an administrative oversight, the ISO failed to file this motion by the date specified in the November 10, 2004 Notice of Filing. Given the early status of the proceeding, however, no party will be prejudiced by the granting of the motion.
