**MOTION OF THE
CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION
FOR EXTENSION OF TIME TO FILE
COMPLIANCE FILING**

Pursuant to Rule 212 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.212, the California Independent System Operator Corporation ("ISO") hereby submits the instant motion for an extension of time to submit the compliance filing that is required by the Commission's "Order Accepting Notices of Cancellation and Rate Schedules, Subject to Compliance" issued on December 3, 2004 in the captioned proceeding ("December 3 Order").¹ That Order required the ISO to submit a compliance filing within 30 days of the issuance of the Order, *i.e.*, by January 3, 2005.² By the instant motion, the ISO requests a seven-day extension of time, *i.e.*, until January 10, 2005, to make the compliance filing.

The ISO submits that good cause exists to grant the ISO an additional seven days to make its compliance filing. Due to the Western Area Power Administration – Sierra Nevada Region transition to the Sacramento Municipal Utility District Control Area, thereby changing the ISO's Control Area boundaries, and due to the December holidays, the ISO personnel needed to complete the compliance filing were not available during the 30-day time period stated in the December 3 Order.

Wherefore, for the foregoing reasons, the ISO respectfully requests that the Commission grant the instant motion and establish a due date of January 10, 2005 for the ISO's compliance filing.
