NOTICE OF AGREEMENT REGARDING ADDITIONAL DISCOVERY

To: The Honorable H. Peter Young

The California Independent System Operator Corporation (“ISO”) hereby provides notice that, due to the inability to schedule the deposition of Mr. Jim McIntosh prior to the last date for discovery under the Procedural Schedule issued on March 10, 2005 in the this proceeding, the ISO has agreed to respond to certain additional discovery. Notwithstanding the requirement of said Procedural Schedule that the last day for discovery is May 16, 2005, the ISO will respond to discovery requests (including those in the form of interrogatories, document requests, and requests for admissions) submitted during a period of ten business days, commencing on the day following the end of Mr. McIntosh’s deposition. The ISO will only respond to discovery requests concerning (1) information (including data, facts, opinions, and ISO positions, or perceived contractions to or changes in data, facts, opinions, and ISO positions) educed

through Mr. McIntosh's deposition that had not previously been provided to parties through testimony or discovery; or (2) Mr. McIntosh's rebuttal testimony.

Objections to such discovery requests will be due in three calendar days, and responses in five calendar days. The ISO will exercise all best efforts to respond in a timely manner. The ISO reserves the right to make any and all objections otherwise available to it to the discovery requests submitted.
