NOTICE OF WITHDRAWAL OF PROTEST OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION TO THE REFUND REPORT OF GEYSERS POWER COMPANY, LLC

Pursuant to Rule 216 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. §§ 385.216, the California Independent System Operator Corporation ("ISO") hereby requests to withdraw its protest filed on August 1, 2002, in the above-captioned docket ("Protest").

In its Protest, the ISO contested a refund report filed by Geysers Power Company, LLC ("Geysers") as a result of a settlement regarding 2001 rates pursuant to the Must-Run Service Agreement ("RMR Agreement") between the ISO and Geysers. The ISO objected to an offset by Geysers from the refund amounts owed pursuant to the settlement agreement and noted a minor mistake.

On August 15, 2002, Geysers filed a Motion for Leave to Submit Answer and Answer in which it admitted that \$3,845,281.99 is the correct total invoice amount for March 2001. The Geysers Answer incorrectly indicates that the difference between the amounts set forth in the refund report was an increase in the outstanding amount owed by the ISO to Geysers. Rather, because of the refund, the difference was an increase in the outstanding amount owed by Geysers to the ISO. In any event, the CA ISO has received from Geysers a Revised Adjusted RMR Invoice for March 2001 setting forth the correct amount. Accordingly the minor mistake has been addressed.

On July 22, 2003, Pacific Gas and Electric Company ("PG&E") and Geysers entered a stipulation ("Stipulation") with the U.S. Bankruptcy Court for the Northern District of California, San Francisco Division, Case No. 01 30923 DM ("Bankruptcy Court"). The Stipulation addressed the offset amount at issue in this proceeding. On July 25, 2003, the Bankruptcy Court approved the Stipulated Order. On August 19, 2003, PG&E withdrew the protest that it filed in this matter.

The Stipulation resolves these particular issues from the standpoint of the ISO because, under the RMR Agreement and the ISO Tariff, the refund amount should flow to the Responsible Utility, in this case PG&E. Moreover, the RMR Agreement provides that PG&E is, to the extent set forth in the RMR Agreement, a third-party beneficiary of the ISO's rights under the Agreement, and shall control the disposition of all claims against Geysers for non-payment. See RMR Agreement section 9.6.

In sum, the issues that led to the CA ISO's protest have now been

resolved, specifically: Geysers has submitted a Revised Adjusted RMR Invoice

with the correct total invoice amount of \$3,845,281.99 for March 2001 and

PG&E and Geysers have addressed the other items at issue in the refund report.

Therefore, the CA ISO respectfully requests that the Commission allow the ISO

to withdraw its protest on these matters.
