On July 14, 2025, as supplemented on October 3, 2025, California Independent System Operator Corporation (CAISO) submitted revisions to Appendix A, KK, LL, and MM of CAISO's Open Access Transmission Tariff¹ in compliance with the directives in a May 15, 2025, Commission order² and the requirements of Order Nos. 2023 and 2023-A.³ Pursuant to authority delegated to the Director, Division of Electric Power Regulation – West under 18 C.F.R. § 375.307, the submittal is accepted for filing effective May 17, 2024, as requested.

The filing was publicly noticed. No protests or adverse comments were filed. Pursuant to Rule 214 of the Commission's regulations (18 C.F.R. § 385.214), notices of intervention, timely-filed motions to intervene, and any unopposed motions to intervene out-of-time filed before the issuance date of this order are granted.
